Operational controls

Applies, in the implementation of business processes, the operational controls necessary to guarantee the protection of the Environment and the prevention of pollution, considering Life Cycle logics.

Emergency response

Is prepared and trained to respond to environmental emergencies that may arise in the implementation of processes.

Monitoring and improvement of the EMS

Constantly monitors the degree of compliance of the Environmental Management System through:

- Internal and/or external audits;
- Correction of non-conformities and implementation of corrective actions;
- The periodic review of the Environmental Policy and Management System;

Specific implementations of environmental performance improvement programmes related to its significant environmental aspects.
